1. HDSC Call to Order - 7:08 pm
2. Roll Call - Patrick Andras, Chris Kraska, Leo Derdelakos, Tammis Donaldson, Rob Duchene, Eric Romain, Carol Schwanger

3. Approval of Agenda – March 23, 2023 - Rob Duchene made a motion to approve the agenda for March 23, seconded by Leslie Snow. APPROVED
4. Approval of Minutes – January 19, 2023 - Rob Duchene made a motion to approve the minutes from January 19, seconded by Chris Kraska. APPROVED
5. Public Comment - Brigitta Burguess attended the meeting after seeing the meeting date posted on the City website. She is interested in Royal Oak history and its historical groups. Carol Schwanger and the HDSC provided an overview of the City's groups (both appointed and volunteer) and how she could get involved.
6. Report from Eric
 - a. 100-year house plaque - The Historical Society of Michigan offers a plaque program for homes that are 100 years old and are in substantially original condition. The plaque is available for a fee if the home is approved. Some research and documentation is required. The application available on through the HSM's website.

 - a. Historical Commission updates - The Orson Starr House Civil War Day will be held on Saturday, May 20 from 11am-5pm. Side porch plans are ongoing and are waiting on a certificate of appropriateness from the HDC in order to proceed with construction.
