

# Art Fair 2026 - Terms and Conditions

## Art Fair 2026 - Terms and Conditions

*Please read the full Terms & Conditions and agree at the bottom of the form.*

### Eligibility

- Participation is open to artists creating original, handcrafted art.
- Each exhibitor must submit an application and digital images for jury consideration.
- Only artists accepted through the jury process may exhibit; substitutions, proxies, or "guest artists" are prohibited.
- Work shown must be consistent with the images submitted and accepted.
- Artists may not exhibit work in categories that were not submitted to the event's jury and approved.

### Accepted Media

- Accepted categories typically include painting, drawing, photography, sculpture, printmaking, mixed media, ceramics, glass, wood, metal, and jewelry (fine art jewelry only).
- All work must be original in concept and execution.
- Limited edition prints or reproductions are permitted only if:
  1. They are clearly labeled as reproductions.
  2. They are signed.
  3. They constitute no more than approximately 1/3rd of booth content.
- Commercially manufactured or mass-produced items (T-shirts, posters, or copies of original works) are not permitted.

### Jury and Compliance

- All artists are selected through a jury process based on artistic merit, originality, and craftsmanship. Other factors such as media variety will also be considered by the organizers.
- Jury fees are due at submission.
- Jury decisions are final. No exceptions.
- The organizers reserve the right to remove artists, without refund, for work that differs from juried submissions, violates rules, or is deemed inappropriate.
- Non-compliance with the Terms and Conditions may result in the removal from the event without refund and disqualification from future participation.

### Artist Presence

- The accepted artist must be present for the entire duration of the show.
- Representatives, agents, or employees may not attend in place of the artist.
- Artists must personally staff their booth during show hours and maintain a professional demeanor with the public, event staff, and fellow exhibitors.

### Booth Display

- Artists must provide their own tent, walls, display panels, lighting, and furnishings.
- All display equipment must be professional, clean, and secured.
- Artwork, bins, and displays must remain within the assigned booth space and not obstruct walkways.
- Storage materials, boxes, and personal items must be concealed or behind the booth space.
- Booth sharing or subleasing is not permitted.

### Sales and Taxes

- All transactions are conducted directly between the artist and the buyer.
- Artists are responsible for collecting and remitting applicable state and local sales taxes.

- All artwork must be clearly priced.
- The event collects no commission on artist sales.

## Setup and Breakdown

- Setup times will be assigned and communicated in advance. Artists must adhere to these scheduled times.
- Vehicles may enter for loading/unloading only during designated setup hours and must be moved prior to fair hours.
- Booths must remain intact until the official closing time on the final day. Early take down before closing is prohibited unless otherwise communicated by the organizers.
- Artists are responsible for picking up their booth space after teardown.

## Weather and Event Continuity

- This is a rain-or-shine outdoor event. Artists must be prepared for varying weather conditions, including wind, rain, and heat.
- Refunds will not be issued due to inclement weather, poor sales, or other acts of nature.
- The event reserves the right to delay, shorten, or cancel the event for public safety in the event of severe weather or other emergencies.

## Insurance and Liability

- Artists exhibit at their own risk. The event, its organizers, sponsors, and venue, assume no responsibility for loss, damage, theft, or injury. Overnight security is provided by the organizers.
- Artists are strongly encouraged to carry general liability insurance.
- Artists agree to hold harmless the event organizers, staff, volunteers, and sponsors from any claims or damages arising from participation.

## Cancellations and Refunds

- Jury fees are non-refundable once an artist has submitted.
- Withdrawals prior to Friday, May 29, 2026 are eligible for a booth fee refund only.
- No refunds will be issued for failure to attend. Refunds after the withdrawal date may be considered on a case-by-case basis by the organizers.
- The event reserves the right to cancel or modify the show in whole or part due to safety, legal, or logistical reasons.

## Image Use and Promotion

- Artists grant permission for the event to use submitted images and photographs taken during the event for promotional purposes (website, print, and social media).
- The artist retains all copyright and reproduction rights to their work.

## Code of Conduct

- Artists must conduct themselves professionally and respectfully at all times.
- Disruptive, aggressive, or unethical behavior may result in immediate dismissal.
- Music, demonstrations, or activities that interfere with neighboring booths are prohibited.
- Smoking and vaping are not permitted within booth areas.

## Agreement

- By submitting an application and paying fees, the artist acknowledges they have read, understood, and agree to abide by all Terms and Conditions stated herein.
- Failure to comply with these policies may result in removal from the show, forfeiture of fees, and exclusion from future events.
